The Director CDOE briefed the CIQA members that the UGC-DEB portal for seeking approval to start the ODL & OL mode programmes is expected to open in the 2nd week of March 2023. The CIQA members were requested to examine the following documents prepared for launching the BBA and B.Com programs by the department of Business Studies under the CDOE.

- 1. Program Project Report (PPR) prepared for each program (BBA/B.Com).
- 2. Self-Learning Material (SLM) prepared for various courses to be offered under CDOE.
- First two years syllabi prepared by inhouse faculty after the quality audit conducted by QAC and plagiarism checks.
- 4. Video recorded lectures after editing and Quality checks by QAC
- 5. All learning material in line with the 4-quadrant approach.
- 6. User id for CANVAS LMS for one student and faculty to be provided by Head (IT Cell).

The above-mentioned documents (PPR, SLM's, and edited videos, etc.) were presented by the faculty members in front of the CIQA committee. The documents were cross-checked by the CIQA committee and **found to be in order**.

The committee **recommended the QAC quality checked data and recorded videos for uploading on the UGC-DEB portal**. The CANVAS LMS was reviewed for the 4-Quadrant approach and was found suitable with all the built in features such as e-Tutorial availability (where video and audio files can be uploaded), e-Content uploading (where digital self-learning materials in the form of ppts, e-books, case studies can be provided), availability of discussion forum (for doubt clearing sessions and general discussion) and assessment module (where quizzes, assignments, MCQ's etc. can be easily prepared and evaluated).

Meeting ended with the vote of thanks to the chair.
